## ***ELIGIBILITY REQUIREMENTS***

**MEMBER & ASSOCIATE MEMBER:** Full membership is open to installing contractors of fire sprinkler companies, certified in Georgia to design and install automatic fire sprinkler systems, or suppliers to the fire sprinkler industry, as long as said contractors, or suppliers are current members of the American Fire Sprinkler Association (AFSA). Members shall have full voting rights, may hold office in the GFSA and shall be eligible for appointment to Standing Committees of the GFSA.

**PROFESSIONAL MEMBER:** Society of Fire Protection Engineer, Designers and Authorities Having Jurisdiction related to the fire sprinkler industry in Georgia who are current members of the AFSA are eligible for membership in this category. Professional Members have NO voting rights, nor hold office in the GFSA, but shall be eligible for appointment to Standing Committees of the GFSA.

**LONG DISTANCE MEMBER:** Full membership is open to installing contractors of fire sprinkler companies with their office located within Georgia and over fifty (50) miles from the State Capitol, certified in Georgia to design and install automatic fire sprinkler systems, or suppliers to the fire sprinkler industry, any of whom are current members of the AFSA. Long Distance Members shall have full voting rights, may hold office in the GFSA and shall be eligible for appointment to Standing Committees of the GFSA.

## ***STATEMENT BY APPLICANT***
